FUNCTIONING & REPRESENTATION HARYANA EX-SERVICEMEN LEAGUE

Sir,

1. It is indeed a proud moment for me to assume the duties of the Administrator of Haryana Ex Servicemen League for managing affairs & conducting election of the Collegiums as well as the Governing Body of HESL under Section 39(10) of HRRS Act 2012. Notwithstanding above, I do take the opportunity to inform that I have also been appointed as the Enquiry Officer to examine the irregularities in membership & constitution of collegiums by various District Ex Servicemen Leagues in Haryana.
2. The HESL, through its Administrator do acknowledges receipt of emails from the President of Indian Ex Servicemen League in recent past and would like to update on the status of functioning & representation of the HESL at various forums including at IESL.
3. **Registration & Regulation.** The Haryana Ex Servicemen League is registered & regulated by the Haryana Registration & Regulations of Societies Act, 2012 & Rules 2012 and, therefore, the management & the Administrator shall work strictly under the provisions of the Act under reference.
4. **Affiliation to IESL.** The HESL has been affiliated to the Indian Ex-Servicemen League, 9 Nyaya Marg, Chanakyapuri, New Delhi with "*distinct autonomous status*" and, therefore, any member nominated by the HESL serves as its representative or delegate on any public body or any other national/international body at the sole discretion of the HESL as well as on advice given by the President and in present case, by the Administrator.
5. **Conduct of Election.** The IESL is apprised that the election of Collegiums couldn't be held on due date and thus the Administrator has been appointed to validate the irregularities in membership and conduct election thereafter and; till then the affairs of


HESL would be managed by the Administrator as directed by the Competent Authority i.e. Lt. District Registrar (Firms & Societies), Rohtak (Haryana).

6. **Representing of HESL.** The HESL would continue to be represented by the Administrator with all legal rights as well as by its delegates including Col TC Dahiya (Retd), who has been removed from Executive Committee vide letter IESL/164/2025 dated 17 Nov 2025 until and otherwise replaced by elected or nominated representatives/delegates by the HESL. Therefore, change of delegates, if any from HESL would be intimated immediately on occurrence.

7. **Removal of Col TC Dahiya (Retd).** The HESL strongly object the removal of its delegate from Executive Committee without consultation and consider it as absolutely unethical and violation of laid down procedure. The HESL would humbly request to revoke the said removal immediately, failing which the HESL reserves the right to challenge the decision of the President of IESL in the Court of Law.
